





I know Liz was an admirer and friend of Norma's, I know Liz to be a woman of high ethical standards - especially when it comes to administering financial aid. Her philosophy can best be summed up as "just because you can, doesn't mean you should".

Liz's commitment to quality postsecondary vocational training doesn't stop at the door of Central Coast College. For many years we've had to share her with the Accrediting Council for Continuing Education and Training (ACCET) as a Commissioner, then as Chair of the Commission, and now as a volunteer.

Liz doesn't just sit in her financial aid "silo". She meets with each admissions representative and goes over prospective students' files in detail to ensure that they can benefit from training, asking about everything from child care to transportation. If the "devil is in the details," I'm pretty sure Liz has slapped him upside the head with a two-by-four more than once. She was one of the first to catch on to the high school diploma mills that plaque students and institutions

Liz also oversees instruction. She sits in meetings about at-risk students and assists in counseling them when we just don't get through. She'd rather have great placement than great retention – not because it looks better, but because she is absolutely dedicated to making sure every student gets his or her money's worth. I've seen her refund tuition she didn't have to because it was the right thing to do. On the flip side, she often has the uncanny ability to see something in a student we're ready to drop and send him right back to the classroom, filling us in on some life circumstance we knew nothing about until she talked with him.

She's an absolute stickler about value in what goes on in the classroom. She is dedicated to continuous improvement to make the training more hands-on and more engaging for students.

Liz sees the whole cycle through, helping supervise Career Services. They meet with her weekly; the list of job-seekers is dissected one by one with a status update on each. Another Lizism: "We never give up on a student finding a job."

Here's just a short list of what I've learned from Liz in the last 13 years:

"Just because you can" give a student the maximum amount of loans available, doesn't mean you should.

"Just because you can" admit a prospective student who's stunningly unsuited to her program choice, doesn't mean you should.

"Just because you can" hire an instructor with a Master's degree and no real world experience over one with an AA who's spent twenty years working in her field, doesn't mean you should.

"Just because you can" delegate the grunt work of reviewing FAFSA's and ISIRs, doesn't mean you should.

"Just because you can" curse the darkness of the regulatory nightmare we're living with and use it as an excuse for discouragement and failure - well, she wouldn't have a minute of that. Her stance is, "well then, we're just going to do it." We all follow her lead.

Prior to employment at Central Coast College, Liz worked in public education, beginning as a Teacher and working her way up through a succession of positions at the school site and district levels including Bilingual/ESL Resource Teacher, Coordinator of Bilingual Education, Coordinator of Instructional Services, Director of Curriculum, and Elementary School Principal.

Liz was a protégé, and became a close friend, of Norma Ford, for whom this award was named. Norma Ford, and Sally Samuels of FAME, provided Liz with her first exposure to training in financial aid and continued to be good friends and mentors throughout the next several decades. Liz continued a close personal and business friendship with Norma until Norma's untimely death in 2010.

Liz earned a BS in Education at Oregon State University, and a K-12 Administrative Credential and Masters in Multicultural Education at the University of San Francisco. She is a strong supporter of the career school mission of "train and place" and the peer review process exemplified by ACCET. A former Chair of the ACCET Commission, Liz volunteers for the commission and does several on-site accreditation visits each year.




