RE: Background on protocols to handle excessive regulation by the Obama Administration

DATE: December 8, 2016

The focus of this memo is on those regulations which were ideological targets by the Obama Administration against proprietary schools and now align with the new Administration's and Department of Education's focus on deregulation: Gainful Employment (GE), Borrower Defense to Repayment (BDR) and State Authorization. Our research suggests that four options exist to address these regulations:

- 1. Withdraw the State Authorization rule.2
- 2. Rescind or modify a regulation via a new notice-and-comment rulemaking.
- 3. Not enforce a regulation until Congress addresses the issue.
- Use the Congressional Review Act (CRA) to overturn a regulation.<sup>3</sup>

These new provisions will apply to ACICS-accredited institutions and follow <u>U.S. Secretary of Education John B. King Jr.'s final decision to withdraw federal recognition</u> of the accrediting agency.





## In Early Moves, Education Department **Erodes Some Student Protections**

In a letter to Congress, more than 50 consumer-protection, civil-rights, and college access and advocacy organizations expressed worry over the early moves by the department and the erosion of student protections. "We believe protections for students and taxpayers should be strengthened, not scaled back," the letter said. A decision to delay, weaken, or repeal the gainful-employment ruling, the group said, "would lead to a new race to the bottom as unscrupulous schools compete to enroll as many students as possible without regard to the quality of the training, the student's preparation, or the job prospects."

### 'Fox Guarding the Henhouse'

Sen. Elizabeth Warren, the Democrat from Massachusetts, has emerged as one of the more prominent voices criticizing the department's early moves on higher education. Along with several other senators, Ms. Warren has sent a series a letters regarding the higher-education task force to be led by Jerry Falwell Jr., the decision to delay gainful-employment enforcement, and, most recently, the employment of Taylor Hansen, a former for-profit lobbyist, and Robert S. Eitel, an executive at a corporate owner of for-profit colleges. In the


